The following terms apply to this sale:

- 1) Breeder agrees to supply the following documents: Veterinarian Health Certificate, Copies of OFA & CERF certificates on parents, copies of parents Pedigrees, a signed copies of both the Breeder Guarantee, the Deposit & Sales Contract, a record of all shots and de-worming and a receipt. Breeder will register the pup and the microchip, in the new owners name, upon purchase.
- 2) Buyer agrees to have said pup/dog examined by a Licensed Veterinarian; at buyers expense, within 48 hours of receipt. In the unlikely event that a contagious disease is detected, breeder is to be notified immediately! Buyer may return said pup to breeder; at buyers expense, with registration papers & letter from Licensed Veterinarian, for a **refund** of the **pet cost**, minus shipping. No exchange pup would be offered in the event of a contagious disease, as the entire litter may have been effected.
- 3) Buyer agrees to a **\$500 deposit (U.S. Postal Money Order, or Paypal)** to reserve said pup/dog and that the deposit is **Non-Refundable**, unless something should happen to said pup/dog while in breeders care.
- 4) If shipping is needed, total cost will include flight, health certificate and shipping crate. **American Airlines or Delta Pet First** will be used when possible, please read shipping costs, on page one.
- 5) All balances are due by the time the pup reaches **6 weeks** of age. Balances must be paid via **Cash, U.S. Postal Money Order, or Paypal**, and must be received **prior** to shipment - **No Exceptions!**
- 6) We have bred; to the best of our ability, a quality representation of the Labrador Retriever breed. There is no guarantee that any pup/dog sold is of show quality, will retain any specific size/weight/color, or is capable of breeding or whelping a litter at maturity.
- 7) **Under no circumstances is this pup/dog to be surrendered to an animal shelter or rescue organization. This dog is NEVER to be re-sold, or otherwise rehomed! If buyer is unable to keep their dog, it MUST be returned to the breeder, no monetary compensation will be given. As the breeder, we agree to provide a forever home, (return shipping is at owners expense), or to assist in the replacement of the dog once spayed/neutered.**
- 8) Breeder assumes no responsibility for veterinary, or any other expenses incurred once said pup/dog leaves breeder's premises.
- 9) Included in the cost of your pup, is the AKC Registration, the Microchip and the chip registration. This will all be done by the breeder. **All pups will carry the Breeders name, prior to chosen name! Ex: Parracino's Chocolate Lab.**
- 10) **All pups sold with a Limited Registration, will be Spayed/Neutered by 9 months of age. Written verification from a Licensed Veterinarian, is required to be submitted to the breeder. All adults will be spayed or neutered prior to leaving, at a cost of \$100.**
- 11) **It is understood and agreed upon, that any dog, male or female, sold by Parracino's Labs, will never be bred to another dog, that is or carries for the dilute gene, (silver). NO EXCEPTIONS! It is also agreed, that no dog male or female, will be bred prior to having their hips & elbows, certified by OFA or PennHip.**
